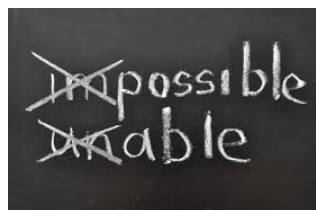

Many Service Providers who attended the Recruit, Hire, Train, and Retain Class requested clarification about the training requirements.

A key take away was that all Employment Professionals including those providing Employment Path services (ie. Sheltered Workshop Staff) need to complete the training requirements (ie. Discovery, Systematic Instruction, Job Development, and SS Benefits).

Further clarification was requested about how Service Providers can obtain approval/certification for their in-house training. Stephanie Roncal, DHS, indicated that ACRE certification would be the avenue. ODDS is not in a position to approve or certify the classes.
