CESP OPPORTUNITIES MORE IM-PORTANT THAN EVER!

According to Corissa Neufeldt with DHS, VR is asking vendors to have CESP or ACRE certification. This is above the DHS requirement for one person to have CESP, ACRE or equivalent certification within a Service Provider organization. So, sign up as many people as you can for CESP exams in September and October where the first 125 people who pass and turn in documentation to WISE that they attended one of the WISE sponsored opportunities (listed

above) and passed by November 30, 2015 can get reimbursed for the exam fee. ACT NOW!
