If you're a little behind on your goals there is time to catch up! Network with some of these folks and get ideas or ask your primary consultant, me, or the many others doing training and technical assistance!

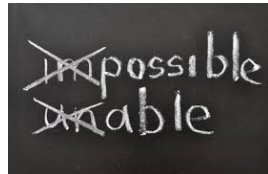
